# BROADCASTING CONDITIONS FOR INVOLVED PARTIES IN BROADCASTS

for ORANGE 94.0 (Freies Radio Wien)

Parties involved in broadcasts are those who participate in the production of a broadcast (both live and pre-produced)

and

have not signed a separate specific arrangement as a radio host.

## BROADCAST, BROADCASTING SLOT, LENGTH OF SLOT

The involved parties have no claim to broadcast based on this agreement. The allotted time slot and length of the broadcast derive entirely on the specific agreement between ORANGE 94.0 and the involved parties of the particular broadcast.

### **EDITORIAL AND ORGANISATIONAL RULES**

The involved parties ensure that the content of their broadcast do not conflict with legal or contractual obligations and do not interfere with the rights of third parties. They commit themselves to observe the rules and regulations in their respective versions. These are legal obligations on the one hand, specifically the Strafgesetzbuch [penal code], the Allgemeine Bürgerliche Gesetzbuch, copyright laws, the Datenschutzgesetz and the General Data Protection Regulation as well as specifically the Privatradiogesetz [private radio laws] and Mediengesetz [media laws]. On the other hand, these include the follwing self imposed rules: the principles of journalistic work (honour code of the Austrian press council), the Charta of the Association of Free Broadcasters in Austria, the General Directives of ORANGE 94.0, as well as the house and studio rules of ORANGE 94.0. ORANGE 94.0 offers regular workshops and further education possibilities for both the legal situation, as well as journalistic knowhow. The offers can be found at o94.at.

## LIABILITY

The parties involved bear full liability for their content. They bear indefinite liability and ensure to keep ORANGE 94.0 free from all legal action and damage, particularly in respect to their broadcast content.

### TRANSFER OF RIGHTS

With deliverance of a show (as an upload or as a live show) the involved parties (as authors and/or holders of neighbouring rights) hand over all rights of use of the broadcast to ORANGE 94.0 at no cost and non-exclusively. This is irrespective of time or place and includes all rights of use and the pertinent personal rights. Specifically these are the right of reproduction, right of distribution, right of broadcast, including the right of first broadcasting, reporting rights, performing rights, and the right of making available (online rights), as well as the right of editing or modification, each with the right of passing broadcasts on within the usual framework of free radio, particularly for purposes of handover of broadcasting, PR work, educational or research work.
